On December 8, 2004, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by William Karwoski, R.Ph., for a three-month extension of the stay of suspension as provided within the board's *Final Decision and Order* ("*Order*") dated March 10, 1999. Also requested was the removal of any restrictions from acting as a pharmacist in charge, (paragraph 2.c.(3)), which was supported by his employer and therapist. (Currently 8 hours per week are authorized as a pharmacist in charge.) Also requested was the elimination of drug screens, which was supported by his therapist.

Based upon the board's review,

IT IS HEREBY ORDERED that William Karwoski, R.Ph., is granted a three-month stay of the suspension of license #9334 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request to further reduce urine screens required by the *Order*, is granted, to two times, (2x), per month.

IT IS FURTHER ORDERED that the request to the remove or modify the current restrictions from acting as a pharmacist in charge, (paragraph 2.c.(3)), is granted, for a total of sixteen (16) hours per week.
