On August 18, 2004, the Medical Examining Board considered information submitted by the petitioner in regard his license to practice medicine and surgery (#32812), which was suspended pursuant to the Board order dated August 25, 1999. The petitioner's license has been subject to consecutive renewable three month stays since the date of the original suspension. By letter dated June 24, 2004, the petitioner informed the Department that he was moving from the state of Wisconsin with the intent to reside and practice acupuncture and/or medicine in the state of California. The Department was further informed that the petitioner did not intend to continue his random drug screens. The petitioner did not submit a request for a further stay of his suspension, which had expired and was due for renewal on August 1, 2004. Based on all of the information of record herein, the Board finds and enters the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the stay of the suspension of the license of Christopher J. Rasmussen, M.D. (lic.#32812) has expired and based upon the petitioner's decision to discontinue compliance with the Board order, his license shall remain suspended until the petitioner has submitted proof of compliance with the terms and conditions of the Board order.

This Order is effective upon service, which is presumed to occur five (5) days after the date signed below.
