On July 29, 2004, pursuant to the Order dated January 20, 2004, currently in effect against Mardele L. Moore, R.N., the Board of Nursing considered the petitioner's request for a further three month stay of the suspension. Based upon all information of record indicating the results of her drug screens, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that

1. The limited license of Mardele L. Moore, R.N., 102111, to practice RN in Wisconsin is hereby GRANTED for a period of ONE (1) month.
2. The petitioner's therapist shall be requested to re-evaluate the petitioner's use of prescribed benzodiazepines in light of her addiction disorder and to submit a report to the Board on petitioner's fitness to practice.
3. The petitioner is not approved for a home health or a pool nursing worksite.
4. This Order is effective upon the date of signing below and is continuous from the time that the previous stay expired.
