On December 8, 2004, the State of Wisconsin Pharmacy Examining Board reviewed the petition of Andrew P. Rice, R.Ph., for a three-month stay of suspension, as provided within the board's *Final Decision and Order* (“*Order*”) dated September 21, 1999. Mr. Rice also requested to be allowed to act as a pharmacist in charge for an additional 4 hours per week, for a total of (24) hours per week. Mr. Rice may currently act as a pharmacist in charge for a total of (20) twenty hours per week and may open and/or close the pharmacy consecutively. Rice’s employer supports the request for additional hours to be worked.

Based upon the board's review;

IT IS HEREBY ORDERED that Andrew P. Rice, R.Ph., is granted a three month stay of the suspension of license #9594 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request to be allowed to act as a pharmacist in charge for an additional 4 hours per week for a total of twenty (24) hours per week is granted.
