ORDER GRANTING LIMITED LICENSE FOR BOARD-APPROVED REFRESHER COURSE

Petitioner

On September 8, 2005, the Board of Nursing considered the petitioner's request for renewal of his limited license and modification of the Board order dated June 13, 2005, which had denied the renewal of his registered nurse license (#67972). The record indicates that petitioner has failed to comply with the terms and conditions of his original board order dated August 16, 1982 and affirmed in its subsequent orders on January 28, 1983 and March 11, 1983, which extended the time for completion of the board ordered discipline. The original Board order required that the petitioner obtain a chemical dependency assessment at a treatment facility acceptable to the Board and commence treatment and monitoring as determined appropriate by the provider. Based upon all of the information showing petitioner has not complied with his original order, and subsequent orders, the Board of Nursing makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the Order Denying Renewal of Limited License dated June 13, 2005 is hereby AFFIRMED and petitioner shall be required to fulfill the terms and conditions as set forth in the previous orders of the Board, including obtaining an AODA assessment from a certified provider. IT IS FURTHER ordered that Petitioner shall be granted a limited license to take a board-approved refresher course.

IT IS FURTHER ORDERED that upon successful completion of the refresher course the petitioner may reapply for reinstatement of his limited license.
