ORDER GRANTING
REINSTATMENT OF LICENSE
WITH LIMITATIONS

On January 27, 2005, the petitioner appeared before the Board of Nursing to request reinstatement of her expired license (#29907) to practice as licensed practical nurse in Wisconsin. Based upon all information of record herein, which shows that the petitioner had been disciplined in 1993 by the State of Illinois Board of Nursing and restored to active status in 2004 after completion of her probation, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the license of Peggy Schinault to practice as a licensed practical nurse (#29907) in Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the reinstated shall be LIMITED as follows:

1. For a period of one (1) year, the petitioner shall practice only under the direct supervision of a licensed registered nurse.
2. Petitioner shall arrange for her employer to provide formal written reports to the Department Monitor in the Department of Regulation and Licensing, P.O. Box 8935, Madison, WI 53708-8935, on a quarterly basis, which shall assess the petitioner's work performance.
3. Petitioner may not work in home health or for a pool agency.
4. Petitioner shall report to the Board any change of employment status, residence, address or telephone number within (5) days of the date of a change.

Upon completion of one (1) year of active nursing practice under the Board ordered requirements, petitioner may request removal of the limitations upon her license.

This Order is effective upon the date of signing.
