On December 8, 2005, Board of Nursing considered the petitioner's request for review of the denial of her eligibility for the Impaired Professionals Procedure (IPP). The information of record shows that the petitioner's application for the IPP was denied on November 11, 2005, upon receipt of information not available at the time of the petitioner's IPP application. Specifically, the record shows that the petitioner failed to disclose that she substituted sterile water into syringes when she diverted controlled substances from her workplace, which could have endangered the health, safety and welfare of a patient. Based upon this information, including petitioner's explanation for her conduct, the Board now orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the denial of the eligibility of Jennifer M. Johnson, RN, for the Impaired Professionals Procedure is hereby AFFIRMED.

This Order is effective upon the date of signing and constitutes the final decision of the Board in this matter.
