PROCEDURAL HISTORY

On October 21, 2003, the Department of Regulation and Licensing issues its Order Adopting the Stipulation in the above-captioned matter. By the terms of the Department's order, applicant's license (#94-58337) to practice real estate salesperson in Wisconsin was granted under certain limiting conditions. The Order provided that failure by applicant to timely comly with the terms of this limitation and/or any further criminal conviction shall result in the revocation of applicant Preisler's limited real estate salesperson's license.

Mr. Priesler has since March 2004 failed to comply with the reporting requirements of his license to practice as a real estate salesperson. In addition, information received by the Department indicates that Mr. Priesler was convicted of violation of Wis. Stat. §946.41(1) [Resisting or Obstructing an Officer.] Mr. Priesler failed to notify the Department of this conviction.

ORDER

NOW, THEREFORE, IT IS ORDERED that the real estate salesperson's license of Robert J. Preisler (#94-58337) is REVOKED.

This Order shall become effective upon the date of its signing.
