On April 14, 2005, the Board of Nursing considered information regarding petitioner's violation of the terms of a board order dated February 5, 2003, which reinstated her LPN license (#10785) to permit her to participate in a board-approved LPN refresher course. Based upon all information of record herein, including information from respondent and her employer, Reedsburg Physicians Group, indicating that she has been working full-time since August 2004 as an LPN and that she has not completed the board-approved nurse refresher course, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the limited license of KAREN A. DAVIS (lic. #10785) to practice as a licensed practical nurse (LPN) is hereby SUSPENDED.

This order shall be effective five (5) days from the date signed below.
