CONCLUSION

Therefore, the respondent is found to have breached the following Rule within the Counselor Code of Conduct

3.1 A conviction for any felony or misdemeanor relating to the counselor's ability to practice the substance abuse counseling profession shall be grounds for disciplinary action.
