On January 27, 2005, the petitioner appeared before the Board of Nursing to request reinstatement of her license to practice as a licensed practical nurse (#27501), pursuant to the Final Decision and Order, dated October 30, 1992. Petitioner also indicated that she had been approved to take a Board-approved refresher course and requested a limited license to enable her to complete the course. Based upon all information of record herein, including petitioner's history of chemical dependency and admitted mood disorder diagnosis, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petitioner's request for a limited license to complete the refresher course is GRANTED, but petitioner's request for full reinstatement of an unrestricted LPN license (#27501) is hereby DENIED.

IT IS FURTHER ORDERED that the petitioner shall obtain a current psychiatric assessment and evaluation, which shall include a current diagnosis, recommendation for treatment, and prognosis. The petitioner shall also submit verification of her ability to safely return to nursing practice. Petitioner may reapply for reinstatement after she has completed the refresher course and has the required evaluation and assessment, which states that she is safe to practice.
