On April 14, 2005, the Wisconsin Board of Nursing considered the petitioner's request for full reinstatement of her suspended registered nurse license (# 114332). Based upon all evidence of record herein indicating that the petitioner has not fully complied with terms of the original Board order dated January 7, 2000, the Board now finds and makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the license of KATHLEEN M. ROBERGE (lic. #114332) to practice as a registered nurse in Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that petitioner shall be given credit for three (3) years of successful completion of drug and alcohol monitoring by the Minnesota Board of Nursing, however, petitioner must complete the remaining two (2) years of the original five (5) year order of the Wisconsin Board of Nursing. Petitioner may apply for a limited license in Wisconsin to complete the remaining time under her Board order.
