On March 10, 2005, the Wisconsin Board of Nursing considered information, including a letter from Petitioner admitting her relapse and violation of the Board's original order, dated January 7, 2000. Based upon the information of record presented herein, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the three month stay of the suspension of the registered nurse license (#80070) of JEAN K. GOTZMAN is hereby REVOKED. Accordingly, Petitioner's license shall revert to suspended status immediately, pursuant to the terms of the Board's original order suspending and limiting petitioner's license.

IT IS FURTHER ORDERED that the Petitioner may not request reinstatement for a period of one (1) year from the effective date of this order.
