On February 9, 2005, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Mark G. Anderson, R.Ph., for a three month stay of suspension a required by the board's *Final Decision and Order*, (“*Order*”) dated August 9, 2000. Also requested was a modification that would increase the number of hours per week to be worked as a pharmacist in charge to 32, from the current number of 24 hours. This request was supported by his employer. His employer indicates he is currently working for 10 hours every other week as a pharmacist in charge. Anderson’s therapist also recommended terminating individual/group therapy currently required by paragraph 2.b 2. of the *Order*.

Based upon the board's review of the respondent’s petition and the documents submitted therewith;

IT IS HEREBY ORDERED: that Mark G. Anderson, R.Ph., is granted a three-month stay of the suspension of license #9189 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: the request to increase the number of hours per week to be worked as a pharmacist in charge to 32, is granted.
