On May 25, 2005, the State of Wisconsin Psychology Examining Board reviewed the documentation and heard the testimony presented in support of the request by Steven R. Stein, Ph.D., for reinstatement of a license to practice psychology in the State of Wisconsin, as provided in the Board's Final Decision and Order dated December 20, 2001.

Based upon the Board's review;

IT IS HEREBY ORDERED, that the respondent's license to practice psychology be reinstated, with limitations, as follows:

1. The limitations shall be for a period of at least three years.
2. The exemption for practice under Wis. Stat. § 455.02 (2m) (L) does not apply to the respondent and all practice of therapy shall be governed by and comply with the rules of the Psychology Examining Board.
3. During the period of limitation, a licensed psychologist, approved by the Board, who is not in a dual relationship with or employed by the respondent, shall supervise the respondent.
4. The supervising licensed psychologist shall review 25% of the respondent's records of treatment to ensure adequate recordkeeping. The frequency of record review shall be at the discretion of the supervising psychologist but will occur at least four (4) times per year with one of the reviews being unannounced.
5. The respondent shall be responsible for the costs of the supervision plan.
6. The supervising psychologist shall provide a report describing the course of supervision and findings of the record reviews at least semiannually with the department monitor.
