On January 27, 2005, the Board of Nursing considered whether to grant a further three month stay of suspension, pursuant to the Final Decision and Order, dated March 3, 2000, currently in effect against petitioner. The information presented to the Board shows that the petitioner had a positive drug screen for morphine during the previous quarter. Based upon all information of record herein, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the stay of the suspension of the limited license of HOLLY I. DAVIS, to practice as a registered nurse (#128432) in Wisconsin is hereby DENIED and her license is SUSPENDED until further order of the Board.

IT IS FURTHER ORDERED that Petitioner may not reapply for a stay for a period of one year. Petitioner shall have three months of compliance with the Order prior to submitting a request for a stay.

This Order is effective five days after the date signed below.
