On January 27, 2005, the Wisconsin Board of Nursing considered the petitioner's request for reinstatement of a three month stay of the suspension of his limited registered nurse license, pursuant to the Final Decision and Order, dated March 3, 2000. Based upon all information of record herein, which included a statement from petitioner's therapist which indicates that petitioner is not physically able to return to practice, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of a three month stay of the suspension of the limited license of Jack M. Gabor, (lic. # 118692) to practice as a registered nurse (RN) in Wisconsin, is hereby DENIED.

IT IS FURTHER ORDERED that the petitioner may reapply for a further stay upon submission of proof that he is physically able to return to practice.

This order is effective five (5) days after the date signed below.
