On March 10, 2005, the Wisconsin Board of Nursing considered the petitioner's request for reinstatement of a three month stay of the suspension of his limited registered nurse license, pursuant to the Board's order, dated March 3, 2000, currently in effect. Based upon the information of record, which included a statement from petitioner's physician which indicates that petitioner is physically able to perform the duties of a registered nurse, the Board orders as follows:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of a three month stay of the suspension of the limited license of Jack M. Gabor, (lic. # 118692) to practice as a registered nurse (RN) in Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that one (1) year shall be added to the term of his limited license beginning as of the effective date of this order because the petitioner was not compliant with the terms and conditions of his original order regarding urinallysis screens and therapy.
