On October 19, 2005, the State of Wisconsin Pharmacy Examining Board reviewed a petition and supporting evidence submitted by Thomas M. Triscari, R.Ph., for reinstatement of a three month stay of suspension as provided within the board's Final Decision and Order ("Order") dated May 17, 2000. Also requested was a reduction in drug urine screens to one time per week, (currently at two) and reduction in individual/group therapy to two times (2x) per month. (currently at one time per week). In his September 19, 2005, correspondence to the board, Mr. Triscari disclosed that he is not currently working in a pharmacy. Based upon review by the board:

IT IS HEREBY ORDERED that Thomas M. Triscari, R.Ph., is granted a three-month stay of the suspension of license #10029 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request for a reduction in drug urine screens to one time per week, is granted, conditioned upon Triscari continuing to not practice pharmacy. If Triscari wishes to resume the practice of pharmacy he shall first petition the board to review and determine the appropriate level of drug urine screens to be imposed on Triscari upon resumption of practice.

IT IS FURTHER ORDERED that the request for a reduction in individual/group therapy to two times (2x) per month, is granted, conditioned upon Triscari continuing to not practice pharmacy. If Triscari wishes to resume the practice of pharmacy he shall first petition the board to review and determine the appropriate level of individual/group therapy to be imposed on Triscari upon resumption of practice.
