On October 12, 2005, the petitioner appeared before the Medical Examining Board to request a further stay of the suspension of his limited license. Petitioner's therapist, Dr. Lance Longo, appeared on behalf of the petitioner in support of his request for a stay. Dr. Sparr's attorney appeared on behalf of Dr. Sparr and confirmed that Dr. Sparr had agreed to voluntarily dismiss his lawsuit (case # 30607-Green County Circuit Court) and waive all costs, attorney's fees and claim associated with his lawsuit. Based upon the information presented, the Board enters the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petitioner shall be GRANTED a stay of the suspension of his limited license for a period of one month.

IT IS FURTHER ORDERED that the petitioner's stay shall be modified to require the following:

- 1) petitioner shall submit to 5 random urinalysis drug screens per week during the period of his one month stay;
- 2) petitioner shall receive one additional therapy session with a follow-up report from his supervising health provider, Dr. Longo, addressing his compliance with therapy and substance abuse recovery;
- 3) petitioner shall submit a report from his professional mentor, Dr. Yetman, regarding the quality of his medical practice and compliance with the Board order.

IT IS FURTHER ORDERED that the additional information described above shall be submitted to the Departmental Monitor for presentation to the Board at their next monthly meeting when the Board will consider extending Dr. Sparr's stay.

This Order is effective upon the date of signing and is continuous from the expiration of the previous stay.
