On January 26, 2005, the Medical Examining Board considered the petitioner's request for a three month stay of the suspension of his medical license (#35645), pursuant to the Final Decision and Order, dated June 22, 2000. Based upon all information of record herein which shows that petitioner had a positive drug screen during the previous quarter, the Board finds and enters the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petitioner's request for a three month stay of the suspension of his license to practice medicine is DENIED based on his violation of the Board order.

IT IS FURTHER ORDERED that the petitioner's random drug screens shall be increased to 104 times per year (twice weekly). Petitioner may not request a further stay of his suspension until he has shown three months compliance with the terms of the original order.

This Order is effective five days after service of this order which begin from the date signed below.
