On January 27, 2005, the petitioner appeared before the Board of Nursing to request reinstatement of his limited license to practice as a registered nurse license (#128015). Based upon all information of record herein, including petitioner's admission of a relapse in his sobriety and recent in-patient hospitalization, the Board orders as follows:

<u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the limited license of Mark J. LeRoux (lic. #128015) to practice as a registered nurse is hereby DENIED.

IT IS FURTHER ORDERED that the petitioner shall obtain a psychological evaluation and assessment from Dr. Jon E. Gudeman, M.D., which shall include verification of his ability to safely return to practice. Petitioner may request reinstatement when he has obtained the required evaluation and assessment stating that he is fit to practice.
