On June 9, 2005, the petitioner appeared before the Board of Nursing to request a reinstatement and a three month stay of suspension of his limited license to practice as a registered nurse license (#128015). Petitioner had last appeared before the Board on January 27, 2005, to request reinstatement of his license. The Board denied the petitioner's request on February 3, 2005 and required that he obtain a psychological evaluation and assessment, including verification of his fitness to practice. Based on the information presented, which included a favorable psychological evaluation assessment and verification of his fitness to practice, the Board now orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the limited license of Mark J. LeRoux (lic. #128015) to practice as a registered nurse is hereby GRANTED.

IT IS FURTHER ORDERED that the original Board order, dated June 6, 2002, which suspended and limited petitioner's license shall remain in effect.
