On July 27, 2005, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Thomas G. Pire, R.Ph., for a three-month stay of suspension of his license to practice pharmacy, as provided by the terms of the board's *Final Decision and Order*, ("*Order*") dated October 10, 2001. Also requested was termination of group therapy required by paragraph 2.b.(2) of the *Order*, to be supplanted by 1x/month individual therapy, which was supported by his therapist. Pire is currently required to attend individual/group therapy once (1x) per week. Also requested was the granting of eight (8) hours to be worked as a pharmacist in charge per week, pursuant to paragraph 2c.(3) of the *Order*, which was supported by his therapist and employer.

### Based upon the board's review:

IT IS HEREBY ORDERED: that Thomas G. Pire, R.Ph., is granted a three-month stay of the suspension of license # 9468 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that the request to terminate group therapy sessions as required by paragraph 2.b.(2) of the *Order*, is denied.

IT IS FURTHER ORDERED: that the request for the granting of eight (8) hours to be worked as a pharmacist in charge per week, pursuant to paragraph 2c.(3) of the *Order*, is granted. Pire may open or close the pharmacy but not consecutively.
