On November 10, 2005, Board of Nursing considered the petitioner's request for a further three month stay of the suspension of her limited license and modification of her therapy and drug screens pursuant to her Board order dated February 2, 2002. Based upon all information of record, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of suspension of the limited license of Robin Swiggum (Lic.#119898) to practice as a registered nurse in Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for a modification of her therapy to one time per month is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for a decrease in drug screens is DENIED because the petitioner has not shown a minimum of one year compliance with her Board order.

This Order is effective upon the date of signing and is continuous from the date of the previous stay.
