ORDER GRANTING REINSTATEMENT OF LIMITED LICENSE WITH MODIFICATION

On June 15, 2005, the petitioner appeared with legal counsel before the Wisconsin Medical Examining Board and requested modification of the Board order dated December 18, 2003, which suspended and limited his medical license. Information was presented to the Board that petitioner has been offered employment in Oklahoma and has entered into an agreement for limited medical licensure in Oklahoma. The petitioner also presented evidence that he was currently in compliance with the Board order and a statement from his treating psychiatrist which indicated that petitioner does not require chemical dependency treatment. Based upon all information of record herein, the Board finds and enters the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the limited license of JOHN A. FERRIS, MD, (lic.# 33626) is GRANTED.

IT IS FURTHER ORDERED that the suspension of the Petitioner's limited license shall be indefinitely stayed upon the condition that Petitioner practices medicine in Oklahoma in compliance with the terms of his limited license in that state, and in compliance with the requirement for continued psychological care as recommended by his psychiatrist in Wisconsin. Petitioner may obtain his required psychological care from a psychiatrist or psychologist in Oklahoma who is licensed and qualified to provide mental health care. Petitioner shall arrange for bi-annual compliance reports from his provider to be sent to the Department Monitor to verify his compliance with the terms and conditions of this order.

IT IS FURTHER ORDERED that if petitioner should decide to return to practice in Wisconsin, he may be required, in the discretion of the Board, to resume compliance with the terms and conditions of his original Board order in Wisconsin or other conditions as deemed appropriate.

This Order is effective upon the date signed below.
