On July 14, 2005, the petitioner submitted a request a three month stay of the suspension of his practical nurse license (lic.#27768), pursuant to the Board order dated March 1, 2002, currently in effect. Petitioner also requested a decrease in his urine screens. Based upon all information of record presented herein, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the limited license of Lynn Schober (lic. #27768), to practice as a licensed practical nurse is hereby GRANTED for a period of three months.

IT IS FURTHERED ORDERED that the petitioner's urine screens shall be decreased to twenty-eight (28) per year.

This stay is effective upon the date signed below and is continuous from the date of the previous stay.
