On June 22, 2005, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Gerald F. Jennings, R.Ph., license # 10919, for a three month stay of suspension to be granted on his license to practice pharmacy in the state of Wisconsin as provided in the board's *Final Decision and Order* dated November 14, 2001. ("*Order*"). Based upon a review of the petition and the documentation submitted:

IT IS HEREBY ORDERED: that Gerald F. Jennings, R.Ph., license # 10919, is granted a three month stay of the suspension of license #10919 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that Gerald F. Jennings shall provide a copy of the Order to his therapist.

IT IS FURTHER ORDERED: that Gerald F. Jennings shall provide copies of all subsequent board orders to the managing pharmacist at any pharmacy where he is engaged in the practice of pharmacy.

PLEASE BE ADVISED: it is the duty of Gerald F. Jennings to read, understand and follow the terms and conditions of the Order. Gerald F. Jennings is required under the *Order* to comply with its terms and conditions and to petition the Board for modifications to the *Order*. A "Pharmacist-in-charge", means a pharmacist who is physically present in the licensed facility and responsible for the routine operation of a pharmacy for the period of time specified by the managing pharmacist. This means that a pharmacist who works alone in a pharmacy is a pharmacist in charge.
