On December 7, 2005, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Gerald F. Jennings, R.Ph., license # 10919, for a three month stay of suspension to be granted on his license to practice pharmacy in the state of Wisconsin as provided in the board's *Final Decision and Order* dated November 14, 2001, ("*Order*"), and a request by Jennings that he be granted 20 hours to work as a pharmacist in charge. Also requested was a reduction in urine drug screens to a frequency of (48) forty eight times per year. Based upon a review of the petition and supporting documentation submitted:

IT IS HEREBY ORDERED: that Gerald F. Jennings, R.Ph., license # 10919 is granted a three month stay of the suspension of license #10919 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that the request to be granted hours to work as a pharmacist in charge, is granted, for an amount of (16) sixteen hours to be worked per week. Jennings may open and/or close a pharmacy consecutively.

IT IS FURTHER ORDERED: that the urine drug screens required by the *Order* are reduced to a frequency of (48) forty eight times per year.
