On February 9, 2005, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Donald R. Leetz, for a continued three month stay of suspension as provided in the board’s *Final Decision and Order* dated December 11, 2001. (“*Order*”) . Mr. Leetz also requested that paragraph 2.b.(2) of the *Order* be modified allowing him to attend individual/group therapy once every three weeks. [Currently at (2x) two times per month.] The request is supported by his therapist.

Based upon a review of the petition and supporting documentation submitted:

IT IS HEREBY ORDERED that Donald R. Leetz, R.Ph., is GRANTED a three month stay of the suspension of license #10190 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request for modification of paragraph 2.b.(2) of the *Order*, to allow Leetz to attend individual/group once (1x) every three weeks, is granted.
