On September 28, 2005, the State of Wisconsin Dentistry Examining Board reviewed the documentation presented in support of the request by William C. Beaupre, D.D.S., for a three month extension of the stay of suspension and modification of conditions, as provided in the Board's Final Decision and Order dated January 9, 2002.

Based upon the Board's review;

IT IS HEREBY ORDERED that William C. Beaupre, D.D.S., is GRANTED a three month stay of the suspension of License #015-5002052 to practice dentistry in the State of Wisconsin.

IT IS FURTHER ORDERED that the request for modification of conditions reducing the number of counseling sessions to not less than one per month is GRANTED.

Please be advised that the next submission of reports and the petition for an extension of a stay of suspension are due on December 15, 2005.
