On August 11, 2004, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Lance J. Lundstad, for a three month stay of suspension as provided in the board’s *Final Decision and Order* dated June 12, 2002. (“*Order*”) The department monitor informed the board that on August 11, 2004, she spoke with Lundstad, who informed her that within the last two weeks prior to August 11, 2004, he had consumed alcohol, driven and been arrested. The board thereupon denied granting Lundstad a three month stay of the suspension of license #12304 in its order of August 11, 2004.

On April 13, 2005, the board reviewed a petition by Lundstad for reinstatement of his stay of suspension, and supporting documentation. Based upon the board’s review,

IT IS HEREBY ORDERED that Lance J. Lundstad, R.Ph., is granted a three month stay of the suspension of license #12304 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the minimum five years of required practice in compliance with the terms of the *Order* shall recommence effective April 13, 2005. All prior modifications to the *Order* granted by the board are hereby revoked.
