Test results for drug and alcohol monitoring for Lance J. Lundstad evidenced that on May 4, 2005, Lundstad tested positive for ethanol at a rate of .089. The board liaison for monitoring therefore found that Lundstad was in violation of paragraph 2.a. of the board’s *Final Decision and Order* dated June 12, 2002. (“*Order*”) and on May 19, 2005, terminated the stay of suspension for Lundstad. At the board’s December 7, 2005, regularly scheduled meeting, the board reviewed Lundstad’s renewed petition for the granting of a stay of suspension as provided by the *Order*. Based upon the board’s review:

IT IS HEREBY ORDERED: that Lance J. Lundstad is granted a three month stay of the suspension of license # 12304, to practice pharmacy in the state of Wisconsin.

IT IS FURTHER ORDERED: that, the all previous modifications to the terms of the *Order*, currently in place, are hereby revoked. As of December 7, 2005, Lundstad shall recommence the initial start date for compliance with the required practice of pharmacy under the terms of the *Order* for a period of (5) five years.

IT IS FURTHER ORDERED: that Lunstad shall appear at the next scheduled meeting of the board, February 8, 2006, and shall submit to the board at that time documentation from his therapist for his plan of care.
