On September 14, 2005, the petitioner made his annual appearance before the Medical Examining Board, pursuant to the order dated September 2 5, 2002, currently in effect. At the time of his appearance, the petitioner requested a three month stay of the suspension of his license and modification of this his order terminating therapy based upon the written recommendation of his therapist. Based upon all information of record herein which showed petitioner to be compliant with the terms and conditions of his Board order, the Board makes the following:
