On December 7, 2005, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by Gregory J. Teche, R.Ph., for a three month stay of suspension as provided within the board's *Final Decision and Order* dated November 12, 2002. ("*Order*"). Also requested was a reduction in individual/group therapy required by paragraph 2b.(2) of the *Order*, to one session per month. (Currently two times per month.) The modification request is not supported by Teche's therapist.

Based upon the board's review,

IT IS HEREBY ORDERED that Gregory J. Teche, is granted a three-month stay of the suspension of license #10612 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request for a reduction in individual/group therapy required by paragraph 2b.(2) of the *Order*, is denied.
