On May 14, 2003, the Board revoked Oestreich’s stay of suspension. At its October 13, 2004, meeting, the Board reviewed a petition and supporting materials submitted by Oestreich in support of a request that the Board reinstate the stay of suspension in this matter. After review and consideration by the Board, the Board granted a three month stay of suspension and reset to October 13, 2004, the effective date of the *Order* and the commencement of the five years of compliant practice required there under. At its December 7, 2005, meeting, the Board considered Oestreich’s petition to be granted hours to be worked without supervision as a pharmacist in charge. Based upon the Board’s review:

IT IS HEREBY ORDERED: that Duane A. Oestreich, is granted a three month stay of the suspension of license #8131 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that the request for hours to be worked without supervision as a pharmacist in charge is denied.
