On June 9, 2005, the Board of Nursing considered the petitioner's request for a three months stay of the suspension of her limited license and for a reduction in urine screens and change in her work report supervisor. Based upon all information of record herein, showing that the petitioner has been in compliance with terms and conditions of her limited license and her request for reduction in her urine screens is supported by her therapist, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for suspension of the limited license of ELLEN N. LALUZERNE, (# 114082) to practice as a registered nurse in Wisconsin, for a period of three months is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's urine screens shall be modified to 36 times per year and the change in petitioner's work report supervisor is approved.

This Order is effective upon the date of signing and is continuous from the date of the previous stay.
