On November 10, 2005, the Board of Nursing considered petitioner's request for a three month stay of the suspension of her limited license pursuant to her Board order dated January 10, 2003. Petitioner also requested access to Schedule II controlled substances in the course of her nursing duties. Based upon all information of record showing that the petitioner has been in compliance with terms and conditions of her limited license and that modification of her Board order is supported by her therapist, the Board orders as follows:

<u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay suspension of the limited license of ELLEN N. LALUZERNE (# 114082) to practice as a registered nurse in Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that petitioner's request for modification of her order to allow access to Scheduled II controlled substances in the course of her nursing duties is GRANTED.
