On January 27, 2005, the Nursing Board considered the petitioner's request for a further three month stay of the suspension of his limited nursing license. Petitioner has also requested a modification in his therapy requirement. Based upon all evidence of record herein indicating that the petitioner has been compliant and that his therapist supports termination of his therapy, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petitioner's request for a three month stay of suspension of his limited license to practice as a registered nurse in Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request to eliminate his therapy is GRANTED based upon his therapists' recommendation and support.

This order is effective upon the date signed below and is continuous from the date of the previous stay.
