## ORDER DENYING REINSTATEMENT OF REVOKED LICENSE

On January 27, 2005, the petitioner appeared before the Board of Nursing in support of her petition for reinstatement of her nursing license, which was revoked pursuant to the Final Decision and Order, dated April 4, 2003. Based upon the evidence of record and the information presented by petitioner, showing that petitioner had not received any treatment, therapy or continuing education related to professional sexual boundaries, and petitioner does not have a current psychological evaluation nor any verification of her ability to safely return to practice, the Board of Nursing orders as follows:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the revoked license of TAMI K. ROBERTSON, R.N. (lic.#108384) to practice as a registered nurse in the state of Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that petitioner shall submit a current psychological evaluation with a recommendation for therapy, and proof of having received appropriate training, education or therapy from a specialist in professional sexual boundaries, and verification of her ability to safely return to practice, prior to resubmitting a request for reinstatement of her license.
