On March 10, 2005, the Wisconsin Board of Nursing considered the petitioner's request for full reinstatement of her limited license to practice as a licensed practical nurse (#30119), which had been suspended pursuant to the Board order dated September 5, 2003. The information presented to the Board consisted of proof of passage of the DHFS Rehabilitation Review, completion of her continuing education requirement and quarterly work reports for a period of one year.
