On June 9, 2005, the Wisconsin Board of Nursing reviewed the request of the petitioner, Carol J. Majerowski, for reinstatement of her nursing license (# 125475) that was suspended and limited by the Board order dated September 5, 2003.

On December 17, 2004, the Board denied the stay of petitioner's suspension on the basis of information showing petitioner had positive drug screens for controlled substances between September 20, 2004 and November 15, 2004. Petitioner was ordered to show at least three months compliance with the terms and conditions of her limited license prior to requesting another stay of suspension. Based upon the information presented which shows that petitioner is in compliance with the terms of her limited license, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the limited license of CAROL J. MAJEROWSKI, (lic.# 125475) to practice as a registered nurse in Wisconsin, is hereby GRANTED.
