On January 27, 2005, the Wisconsin Board of Nursing considered the request of the petitioner, Robin S. Kisner, R.N, to surrender her license to practice in the state of Wisconsin as a registered nurse, prior to completion of the requirements of the Final Decision and Order, dated September 5 , 2003, which is currently in effect. Based on the information presented, indicating that the petitioner is going to move to the state of New York and is not intending to continue practicing nursing in Wisconsin, the Board now orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the voluntary surrender of the RN license (lic.# 138759) issued to Robin S. Kisner is hereby ACCEPTED.

IT IS FURTHER ORDERED that if the petitioner reapplies for licensure in the state of Wisconsin in the future, her nursing license would be subject to the terms and requirements of the original Board order, which were not completed prior to her surrender.

This Order is effective upon the date of signing.
