On July 27, 2005, the State of Wisconsin Pharmacy Examining Board, ("board") reviewed the petition by Neil T. Noesen, R.Ph., for a modification of the board's *Order Fixing Costs*, ("Order"), dated June 22, 2005. The *Order* requires that costs be paid on or before July 22, 2005. By email correspondence, dated July 12, 2005, Noesen petitioned the board as follows:

Based upon the board's review, IT IS HEREBY ORDERED that the petition is denied.
