On January 27, 2005, the Wisconsin Board of Nursing considered the request of the petitioner for a further three month stay of the suspension of her limited license, pursuant to the Board Order dated January 15, 2004, currently in effect. The petitioner also requested a decrease in her screens, therapy and AA requirements. Based upon all information of record herein, showing that petitioner is in compliance with the terms and conditions of her limited license, the Board orders as follows:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the limited license of MICHELLE M. DONAR, L.P.N., (lic. #29211) to practice as a LPN in the state of Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner therapy requirement shall be modified to two sessions per month.

IT IS FURTHER ORDERED that the petitioner's request for decrease in her screens is DENIED. Petitioner must have three months of normal creatnine levels screens before a decrease in the frequency of screens will be considered by the Board.

This Order is effective upon the date of signing and is continuous from the date of the previous stay.
