On July 14, 2005, the Wisconsin Board of Nursing considered the petitioner's request for a three month stay of the suspension of her limited license (lic.#105822) and a modification in her therapy and access to controlled substances in the workplace. Based upon the information of record herein, the Board now finds and orders as follows:

<u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the limited license of MADGE M. KRUEGER, (lic#105822) to practice as a registered nurse in Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for a reduction in her therapy to two sessions per month is GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for access to controlled substances in the workplace is DENIED based upon her lack of full compliance with the Board order.

This Order is effective upon the date of signing and is continuous from the date of the expiration of the previous stay.
