On April 14, 2005, the Board of Nursing considered information regarding petitioner's violation of the terms of a board order dated November 4, 2004, which suspended her registered nursing license (#66868) and imposed limitations for her rehabilitation, monitoring and treatment. Based upon all information of record herein that petitioner has not been in compliance with the terms of the Board order, the Board finds and makes the following:

### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the limited license of SUSAN L. KJELLAND, RN (lic. #66868) to practice as a registered nurse is hereby SUSPENDED. The period of suspension shall be for a minimum of one year. Petitioner may not re-petition for a stay of suspension without showing compliance with the terms of the Board order.

This order shall be effective five (5) days from the date signed below.
