On July 20, 2005, the State of Wisconsin Psychology Examining Board reviewed the documentation presented in support of the request by Kathleen M. Roblee, PHD, for modification of conditions, as provided in the Board’s Final Decision and Order dated May 5, 2004.

Based upon the Board’s review, IT IS HEREBY ORDERED that: Kathleen Roblee’s modification request to allow her to provide services related to mental health crisis intervention counseling as part of a local, volunteer, Red Cross disaster relief team, and provide two weeks of mental health crisis intervention disaster relief if she is asked to do so at the scene of a national disaster is GRANTED.

IT IS FURTHER ORDERED that Ms. Roblee’s request to provide psychological services to education-oriented groups alone and without a co-therapist is DENIED. If Ms. Roblee desires to provide services alone without a co-therapist, she must do so under the supervision of a licensed psychologist. Prior to commencing the provision of services, the licensed psychologist shall submit a supervision plan to the Board for its approval. The plan must include a description of the ability of the supervising psychologist and treating psychologist to communicate with each other.

All other requirements of the original Final Decision and Order remain in full force and effect.
