DECISION

On May 12, 2004, the Real Estate Appraisers Board issued a Final Decision and Order adopting a Stipulation filed by the parties in the above-captioned matter. The Order set forth in the Final Decision and Order, contains limitations and conditions that the respondent is required to comply with.

On October 19, 2005, the Board considered respondent's request for removal of the limitation and conditions placed upon his Certified Residential Appraiser credential pursuant to the Board's Final Decision and Order, dated May 12, 2004. Based upon the record herein, including documentation submitted by the respondent establishing compliance with the conditions and limitation set forth in the Board's Final Decision and Order, the Real Estate Appraisers Board issued the following order:

NOW, THEREFORE, IT IS ORDERED that the conditions and limitation placed upon the Certified Residential Appraiser credential (#09-1129) of Paul D. Allen pursuant to the Board's Final Decision and Order, dated May 12, 2004, be removed and that respondent's credential be, and hereby is, restored to full certification.
