**DECISION**

On May 13, 2004, the Real Estate Appraisers Board issued a Final Decision and Order adopting a Stipulation filed by the parties in the above-captioned matter. The Order set forth in the Final Decision and Order, contains limitations and conditions that the respondent is required to comply with.

On May 11, 2005, the Board considered respondent's request for removal of all limitations and conditions placed upon his Certified Residential Appraiser credential pursuant to the Board's Final Decision and Order, dated May 13, 2004.
